Sealed bids for the construction of airport improvements - 59th Street Re-Route for the Williston Basin International Airport, Williston, North Dakota will be received by the City of Williston, Williston, North Dakota until 2:00 PM CT on August 16, 2016. All bids will be publicly opened and read aloud at 3:00 PM CT on August 16, 2016 at City Hall, City Commission Meeting Room, 22 East Broadway, Williston, North Dakota. The Owner will receive prime bids for general construction.

The bid documents are to be mailed or delivered to Steven Kjergaard, Sloulin Field International Airport, 402 Airport Road, Williston, North Dakota 58802 and shall be sealed and endorsed, "Airport Improvements - 59th Street Re-Route, Williston Basin International Airport, AIP No 3-38-0084-002-2016" and shall indicate the type and number of contractor's license.

The proposed work includes the following:  
Construction of Re-Routed 59th Street NW around the north side of the airport. This include earthwork, culverts and gravel surfacing.

Plans and specifications are on file and may be seen at the office of Steven Kjergaard, Sloulin Field International Airport, 402 Airport Road, Williston, North Dakota, at the office of KLJ, 820 East Broadway, Suite 2, Williston, North Dakota and at the office of KLJ, 4585 Coleman Street, Bismarck, North Dakota.

Complete bidding documents are available only in electronic form, and may be viewed online and downloaded without charge and without deposit from Submittal Exchange at <https://www.submittalexchange.com/bid/151551259thStreet/PlanRoom>. Bidders must register through the website to obtain the bidding documents and be notified when addenda are posted. Bidders are solely responsible to obtain all Bid Documents and Addenda being made available on the website. Bidders may print the downloaded files and are responsible for all printing and reproduction costs. Addenda to the Bid Documents will be posted on the website; bidders are responsible to periodically check the site for addenda. The Contractor that is awarded the project will be responsible for printing all documents necessary for performing the work.

Each bid shall be accompanied by a separate envelope containing a Bid Bond in a sum equal to five percent (5%) of the maximum bid price, executed by the Bidder as principal and by a surety company authorized to do business in the State of North Dakota, payable to the City of Williston, conditioned that if the principal's bid be accepted and the contract awarded to him, he, within ten (10) days after Notice of Award has been executed, will execute and effect a contract in accordance with the terms of his bid and a contractor's bond as required by law and regulations and determinations of the governing board. The bid security of the two lowest bidders will be retained until the Notice of Award has been executed, but no longer than sixty (60) days. The bid security is a guarantee that the bidder will enter into contract for work described in the Proposal.

The Contractor shall also enclose within the Bid Bond envelope a copy of the bidder's North Dakota Contractor's License or a copy of their latest renewal certificate issued by

the Secretary of State as per North Dakota Century Code 43-07-05 and 43 07 12. Any bid not containing this document shall not be acceptable and shall be returned to the Bidder.

The successful Bidder will be required to furnish a Contract Performance Bond and Payment Bond in the full amount of the Contract.

The City of Williston, Williston, North Dakota, reserves the right to hold all bids for a period of sixty (60) days after the date fixed for the opening thereof to reject any and all bids and waive defects and to accept any bids should it be deemed for the public good and also reserves the right to reject the bid of any party who has been delinquent or unfaithful in the performance of any former contract to the Owner.

The successful Bidder will have to obtain a statement from the Office of the State Tax Commissioner showing that all taxes due and owing to the State of North Dakota have paid before the contract can be executed.

The City of Williston, in accordance with the provisions of Title VI of the Civil Rights Act of 1964 (78 Stat. 252, 42 U.S.C. §§ 2000d to 2000d-4) and the Regulations, hereby notifies all bidders that it will affirmatively ensure that any contract entered into pursuant to this advertisement, disadvantaged business enterprises will be afforded full and fair opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, or national origin in consideration for an award.
